

## «LEMUR» LICENSE AGREEMENT

### IMPORTANT - PLEASE READ CAREFULLY!

Before using the *Lemur* software, which is distributed by the *INSTALF Limited Liability Company (LLC)*, it is necessary to read the following terms of the license agreement. Any use of the software by you means full and unconditional acceptance of its terms. If you do not fully accept the terms of the license agreement, you shall not use the software for any purpose.

### 1. GRANT OF LICENSE

This End User License is a legal agreement between you (either an individual or an entity) and *INSTALF LLC*. *INSTALF LLC* provides you the License Agreement ("License") for using *Lemur* software ("Software"), and you accept a limited, nonexclusive license to use the Software on the terms defined in this Agreement.

For the purposes of this License Agreement, Software includes any updates, enhancements, modifications, revisions, plugins, or additions to the software, available to users through a website (<https://instalf.space>). Notwithstanding the foregoing, the developers are not obligated to provide any updates, enhancements, modifications, revisions, plugins, or additions to the software.

#### 1.1. Installation and Using

By accepting this License, you may download and install a copy of the program on your computer.

#### 1.2. Copies and Modifications

Prohibited the reverse engineering, decompiling, disassembling or any translations of the Software. Prohibited in any way modification or adaptation of the Software. Prohibited from providing or distributing the Software among others. Distribution of the *Lemur* software is only possible through the website (<https://instalf.space>).

#### 1.3. License Grant for Remote Access

1.3.1. To access your licensed copies of the software and its use, you can use remote access technologies (for example, Remote Desktop, Radmin, TeamViewer), provided, however, that using remote access software accesses and uses only the primary

user of the device, to which remote access occurs. These rights do not allow remote access while you use the software on a device that created the remote session.

1.3.2. With the mutual agreement, developers are entitled to access the remote user's machine for maintenance, troubleshooting and debugging the Software, while using remote access technologies (for example, Remote Desktop, Radmin, TeamViewer). The user can provide remote access permanently or on the developer's request.

1.3.3. Users with full "service" license for the Software may request assistance from developers using remote access technologies (for example, Remote Desktop, Radmin, TeamViewer).

#### **1.4. License Grant for Documentation**

Documentation accompanying the software is licensed for internal, non-commercial use.

### **2. DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS**

2.2. During publication of the research results that were obtained with the help of the Software, it is necessary to use the link to the official website (<https://instalf.space>) and/or a citation to publications that were written by developers.

### **3. INTELLECTUAL PROPERTY AND CONFIDENTIALITY**

#### **3.1. Reports, License Violations, and Remedies**

Developers reserve the right to obtain information regarding Software usage, including usernames, IP addresses, and other proprietary information. Unauthorized use of the Software will be considered a breach of this License.

#### **3.2. Property Rights on the Software**

You acknowledge that the Software is the property of the developers and is protected by copyright law.

Developers own all rights and interests in the Software, including associated intellectual property rights in accordance with applicable copyright, trade secret, and trademark laws.

This License grants you limited rights to use the Software, which may be revoked by developers and/or *INSTALF LLC*.

## 4. TERM AND TERMINATION

This License enters into force after you accept its terms, or after you download, access, or use the Software, even if you have not explicitly agreed to the terms of the License. This License remains in effect until terminated.

If you breach any of the License terms, this License will be terminated automatically.

Developers and/or *INSTALF LLC* have the right to terminate this License at any time, and upon termination, you agree to remove the Software from your system.
